Degree Course as State Government Nominee(s) for the academic session, 2026-27 to apply online through departmental website **manipurvety.mn.gov.in** w.e.f. 22nd July, 2026 (9.00 a.m.) onwards. The Candidates/applicants should be a **qualified candidate** in the NEET (UG)-2026 held on 21st June, 2026 conducted by National Testing Agency (NTA) and selection will be based on NEET score card and counselling etc. Detailed information in this regard can be had from the Notice Board of this Directorate, Departmental website and leading local newspapers etc.

Eligibility Criteria:

- a) Should be a qualified candidates in the NEET (UG)-2026 held on 21st June, 2026.
- b) Passed Higher Secondary (10+2) Science Examination / equivalent Examination in all subjects from a recognized Board/Council/University with a minimum of 50% marks of aggregate in English, Physics, Chemistry and Biology for General and OBC categories and 47.5% marks in respect of ST / SC / Person with Disabilities categories in one sitting.
- c) Candidates must have attained a minimum of 17 years & not more than 25 years of age on 31st December, 2026. There shall be relaxation of maximum age by 5 years for Schedule Caste (SC) / Schedule Tribe (ST) & Other Backward Class (OBC) candidates.
- d) Candidate should be a bonafide domicile of Manipur.
