5. Tentative Timeline for the recruitment:

- i) Date of Notification: 29/02/2024
- ii) Date of downloading of Application form: 15/03/2024
- iii) Date of Registration/Submission of Online Application: 22/03/2024
- iv) Last date of Registration/Submission of online Application: 23/04/2024
- v) Issue of Admit Card: Will be notified later on Web portal
- vi) Date of Written Examination: Will be notified later on Web portal

6. Age limit: A candidate must have attained the age of 18 years (21 years for Driver) and must not have attained the age of 38 years on 29<sup>th</sup> February, 2024. The permissible relaxations in upper age limit for different categories are as under:

Categories	Age relaxation
OBC(M), OBC(MP)	3 years
ST	5 years
SC	5 years
PwD	10 years

*Note: The DOB filled by the candidate in the application form must be the same as recorded in their Matriculation Certificate issued by a recognized Board/Council of the State or Central Government.*

All the candidates of all categories who had appeared in the recruitment examinations held on 11/12/2021 and 12/12/2021 vide Notification No. VY/66/HA/2018-Vety (Pt) dated 10.11.2021 and 18.11.2021 shall be exempted from age limit criteria and be allowed to appear in the fresh examination, irrespective of age.

7. Eligibility conditions:

- i) The candidate must be a citizen of India and a Permanent Resident of Manipur
- ii) The candidate must be able to speak Manipuri or any of the notified Scheduled Tribe dialects of Manipur
- iii) The candidate must have the essential qualifications specified for each post.

8. Application fees: Candidates shall have to pay application fee online at the time of submission of forms. The fees payable are indicated as under:

All the candidates who had appeared in the recruitment examination held on 11/12/2021 and 12/12/2021 vide Notification No. VY/66/HA/2018-Vety (Pt) dated 10.11.2021 and 18.11.2021 shall be waived from paying the examination fee while submitting the application form. If the candidate wants to apply a different post other than previously applied, it will be treated as fresh candidate and shall have to pay examination fee,

Application fee is non-refundable and not transferable. After ensuring the correctness of the particulars of the application forms, candidate should pay examination fees through the payment gateway integrated with the application by following the instructions available on the screen.

- i) Permanent Residential Certificate
- ii) Age proof
- iii) Concerned Employment Exchange Office Sponsored Document
- iv) Educational Qualification Certificate along with relevant mark sheets from matriculation and onwards.
- v) SC/ST/OBC/PwD for candidates seeking reservation/benefit available
- vi) Recent photograph
- vii) Valid Driving License issued by competent authority for the post of Driver
- vi) Signature
- vii) No objection Certificate from the employer, if candidates are serving in any Government Department of Public Sector Undertaking/Autonomous Body.

10. How to apply:

Application should be submitted through online mode only by registering themselves only through the application portal link on the Website [www.vetymanipur.nic.in](http://www.vetymanipur.nic.in)

*Note: If a candidate wishes to apply for more than one post, he/she should apply in different application forms and rank them in order of preference in the application form. The fees will be chargeable for each post separately.*
